Deadline to Challenge a Property's Market Value, Classification or Exemption is September 15

Taxpayers were notified this month of their property's assessed and market values in a Truth in Millage (TRIM) notice. If you feel the Property Appraiser's assessment, classification or exemption status for your property is not correct, you have until September 15 to file a petition with the Value Adjustment Board (VAB).


