
## Clerk of the Circuit Court & Comptroller's Self-Service Center



- Clerk of The Circuit Court & Comptroller is the trustee of the county's public records and public funds.

### Parental Responsibility



- Formerly referred to as custody.
- Who makes important decisions in the child's life: school, medical, travel.
- Shared v. Sole
- FS 61.13: Preference for shared unless it would be detrimental to child.

## **Timesharing**

- Also referred to as visitation.
- Schedule child will follow for when they are with each parent.
- FL law states a preference for "frequent and continuing contact with both parents."
- Includes factors court should look at to determine what schedule/contact is in the child's best interest.



## **Parenting Plan**

- Required in all cases involving time-sharing.
- At a minimum must discuss:
  - ☐ How parents will share responsibility for daily tasks.
  - ☐ Schedule that specifies the time the child will spend with each parent.
  - ☐ A designation of who will be responsible for health care and school related matters, and
  - The methods and technologies that the parents will use to communicate with the child.
- Can use safety focused or long-distance parenting plan if applicable.



## **Guideline Child Support Calculation**



- Guideline Calculations based on FS 61.30.
- Shared financial responsibility: Chart uses combined income of parties and # of children to calculate basic need and divides that between the parents based on their % of the income.
- The basic child support obligation may be adjusted based on child-care costs, the child's health insurance premium, timesharing of 20% or more, and ct. ordered child support paid for other children.



## STEP 1 Determine Grounds for Modification



- For both child support and parental responsibility/timesharing there must be a substantial and unanticipated change of circumstances for modification.
- The Court must also find modification is in the best interest of the child.
- For parental responsibility/ timesharing the Court looks at various factors listed in FS 61.13 to determine best interest of child for a modification, such as:
  - ☐ Ability of parent to encourage a relationship btwn child and other parent.
  - ☐ Continuity and routine of child
  - Evidence of domestic violence or child abuse.

## STEP 1 Determine Grounds for Modification (cont'd)



- For private child support cases the difference between existing order and guideline calculation for modification must be at least \$50 or 15%.
- For Dept. of Revenue (DOR) cases modification must be at least \$25 or 10% change to be considered a substantial change.

# STEP 2 Initial Court Filing

For all Post Judgment Modifications:

- ☐ Cover Sheet
- Petition (Supplemental Petition to Modify Parental Responsibility, Time-Sharing Schedule and other Relief **OR** Supp. Petition for Modification of Child Support)
- Notice of Related Cases
- Notice of Social Security Number
- Date of Birth Form
- UCCJEA Affidavit
- ☐ Summons



# STEP 2 Initial Court Filing (cont'd)



- For Child Support Modification:
  - ☐ Financial Affidavit (Short Form: (<\$50k; Long Form: \$50k or >)
  - ☐ Certificate of Compliance with Mandatory Disclosure
  - ☐ Child Support Guideline Worksheet.
- For Parental Responsibility/ Timesharing Modification:
  - Proposed Parenting Plan

## STEP 2 **Special Note: DOR Administrative** Cases



- If you would like to modify a child support order that was ordered administratively by DOR, you must file a **Petition to Supersede and Modify** an Administrative Child Support Order instead of a Supplemental Petition to Modify Child Support. All other forms for initial filing would be the same.
- Filing fee is \$301
- How do you tell if you have an administrative support order?





# STEP 3 Service/ Summons



#### Service

- □ Palm Beach County Sheriff for \$40.00 or Private Process Server.
- Process Service Memorandum
- ☐ If DOR is a party to your case, they must also be served.

#### Publication/Constructive Service

- ☐ If, after due diligence, you cannot locate the Respondent.
- Additional forms required.
- ☐ Fee to publish in newspaper. (Unless determined indigent)

#### STEP 4 Respondent's Answer

#### Answer

- Admit, Deny, or Without Knowledge.
- Or may file an Answer and Counter Petition.
- Must also complete all forms Petitioner did, except for Cover Sheet, Petition, and Summons.

#### **Timeframe**

20 days from date of service of petition.

#### No Response

Clerk's Default







### Step 5 **Mandatory Disclosure**



- Required for petitions to modify support, unless waived in writing by both parties.
- Even if waived, still need to complete financial affidavit form for purposes of calculating support.
- Mandatory Disclosure means parties must exchange certain financial documents (such as pay stubs and tax returns) with each other and file a Certificate of Compliance with Mandatory Disclosure form with the clerk.
- Do not file financial documents with clerk-only file certificate.





#### Mediation



- If no agreement on all issues at this point either party can file Motion for Mediation. Mediation is required.
- Costs- Dependent on Income
  - Combined income of parties:
    - □ < \$50K = \$60
    - □ \$50-\$100K = \$120
    - □ > \$100K = Private mediation
- Mediator can assist with guideline calculations, agreement, and/or Parenting Plan.


# Step 6 Final Hearing/Judgment

- Clerk's Default (if no response file the following):
  - ☐ Affidavit of Military Service
  - Motion for Default
- <u>Contested</u>: Parenting Plan and/or Child Support Worksheet- if not already filed.
- All Cases: Notice for Trial Form

(**NOTE**: A final hearing will not be set until this form is filed.)



### Final Judgment



- Notified by mail of court hearing
- Court will prepare judgment at final hearing
- Bring Final Disposition form to court
